The deadline for ordering your citrus tree is <u>Friday, March 22nd at 4:30</u> p.m. - **no later**. Citrus trees are in limited supply, orders will be filled in the order they are received.


The trees will be distributed on Saturday, April 6th, at the Extension Service barn on the **north side** in Bartow at 1702 Highway 17 South. Distribution begins at 8:30 a.m. and the sale ends at 11:30 a.m. An exhibitor may purchase and register blueberries and citrus <u>but may show and sell only one plant</u> (blueberry or citrus). ONLY blue-ribbon plants will be auctioned.

**PLEASE NOTE**: Trees will not be sold without an order form specifically naming the person buying no more than <u>TWO</u> trees. Each tree will be identified by number which is not transferable. Trees and containers not picked up by 11:30 a.m. on April 6th will be available for purchase first come, first serve, for cost plus late fee after 11:30 a.m. <u>NO REFUND</u> will be made for plants and pots not picked up.

## **Citrus Disease Waiver**

Due to bacterial citrus diseases now found in Florida, a pre-fair inspection must be completed by the Florida Department of Agriculture and Consumer Services. This inspection will be specifically for citrus greening and citrus canker symptoms. Individual trees exhibiting symptoms of either disease will be refused entry into the Youth Fair resulting in disqualification. The decision of fair officials is final in respect to disqualification due to citrus greening and citrus canker.
