We will distribute the citrus trees for the 2021 Youth Fair, on Saturday, April 4, 2020. The variety of tree is Bingo. The deadline for ordering your citrus tree is Friday, March 20<sup>th</sup> at 4:30 p.m. - **no later**.

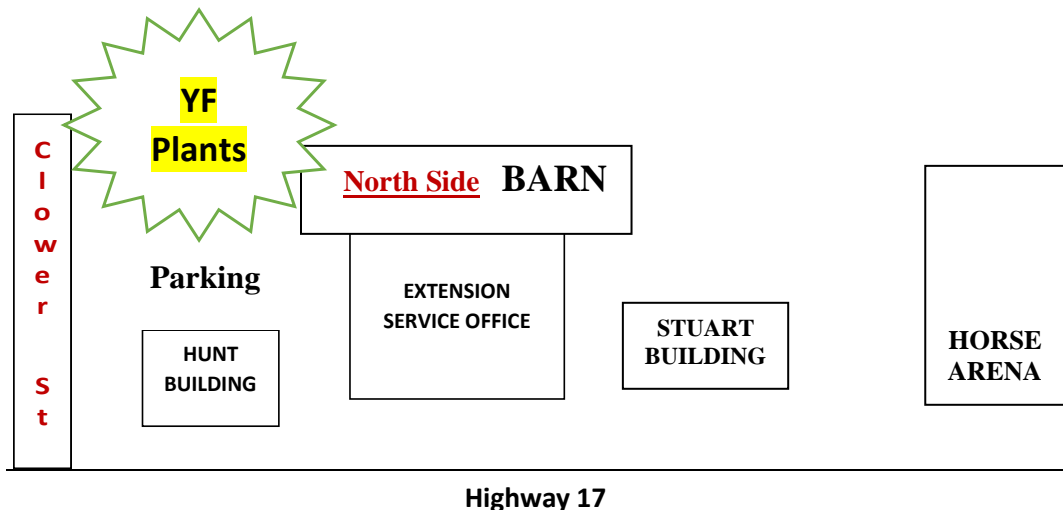
The trees will be **distributed on Saturday, April 4<sup>th</sup>**, at the Extension Service barn on the **north side** in Bartow at 1702 Highway 17 South. Distribution begins at 8:30 a.m. and the sale ends at 11:30 a.m. A Citrus Workshop, featuring suggestions on growing citrus trees in containers will be given starting at 10:15 a.m. **An exhibitor may purchase and register blueberries and citrus, but may show and sell only one plant (blueberry or citrus). ONLY blue-ribbon plants will be auctioned.**

**PLEASE NOTE:** Trees will not be sold without an order form specifically naming the person **buying no more than TWO trees**. Each tree will be identified by number which is not transferable. **Trees and containers not picked up by 11:30 a.m. on April 4<sup>th</sup> will be available for purchase first come, first serve, for cost plus late fee after 11:30 a.m.**

**Citrus Disease Waiver**

Due to bacterial citrus diseases now found in Florida, a pre-fair inspection must be completed by the Florida Department of Agriculture and Consumer Services. This inspection will be specifically for citrus greening and citrus canker symptoms. Individual trees exhibiting symptoms of either disease will be refused entry into the Youth Fair resulting in disqualification. The decision of fair officials is final in respect to disqualification due to citrus greening and citrus canker.
